INFORMATION FOR PET OWNERS

Anti-rabies Vaccination Required § 6-13. Every person owning or having charge, care or control over any dog shall, immediately after his dog attains the age of four months and at intervals of not more than 24 months thereafter, secure the vaccination of such dog by a licensed veterinarian with a canine anti-rabies vaccine of a type approved by the State Department of Public Health.

Any dog may be exempted from the anti-rabies vaccination if its owner presents to the Animal Control Officer a statement in writing from a licensed veterinarian indicating the dog is not in a physical condition to be vaccinated or that the administration of the vaccination would be detrimental to the dog's health. [Certain conditions apply to the exemption—see city code for the list of conditions]

License Required § 6-17. Every person owning or having charge, care or control over any dog shall, after the dog attains the age of four months, secure from the collector a license as and tag for said dog.

License Due date § 6-18. Every person owning or having charge, care or control over any dog of the age of four months or over shall pay a license fee as set by resolution of the City Council, to be paid within thirty days after the owner and the dog establish residence in the City, or within thirty days after the dog reaches the age of four months.
